# A BILL

To amend the CARES Act to extend certain unemployment compensation provisions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SEC. 1. SHORT TITLE.
- 4 This Act may be cited as the "Extend Unemployment
- 5 Assistance Act of 2021".

- 12 money in the Treasury not otherwise appropriated,
- 13 \$2,000,000, to remain available until expended, for the
- 14 Railroad Retirement Board, for additional hiring and
- 15 overtime bonuses as needed to administer the Railroad
- 16 Unemployment Insurance Act.

#### 17 SEC. 16. BUDGETARY EFFECTS.

- 18 Each Federal payment made to a State as a result
- 19 of the amendments made by this Act, and any additional
- 20 benefits paid as a result of such amendments, shall be ex-
- 21 empt from any sequestration order issued under the Bal-
- 22 anced Budget and Emergency Deficit Control Act of 1985.

### 23 SEC. 17. EFFECTIVE DATE.

- Except where otherwise provided, the amendments
- 25 made by this Act shall apply as if included in the enact-

- 1 ment of the CARES Act (Public Law 116–136), except
- 2 that no amount shall be payable by virtue of such amend-
- 3 ments with respect to any week of unemployment ending
- 4 on or before September 6, 2021.
