The funding would be used for construction of a new water treatment plant to serve Randolph and two abutting towns with clean, potable water that meets the requirements of all current and pending Clean / Safe Drinking Water Act regulations. Since the promulgation of the MassDEP MCL Regulations for PFAS6, Randolph has exceeded the PFAS6 quarterly limits twice, requiring notification to the public on two occasions. Due to the unpredictable nature of PFAS6 the town has installed a water vending reverse osmosis unit to provide free PFAS free water access to our 35,000 residents for the impacted population as an interim option while the new regional water treatment plant is completed.
